











North American Division Tithe Gain (Loss) for 10 Years in Dollars








Worldwide Tithe - 2004 through 2015 (in Millions)



2019 - NAD keeps .5% of the next .25% from the GC






North American Division Missions (in millions) For Past 10 Years








North American Division Tithe Gain (Loss) for 10 Years in Dollars





2016 Adjusted Gross Tithe used for the 2018 Tithe Budget



2018 Payroll Assumptions Remuneration Factor








2018 Budgeted NAD Use of Tithe Funds:


