




NAD Financial Statement – Operating Only 2017 - 2013






NAD Financial Statement - Operating & Plant 2017 – 2013






Division Office Finances Working Capital and Liquidity












North American Division Tithe (in millions) For Past 10 Years






North American Division Tithe Gain (Loss) for 10 Years in Dollars






Worldwide Tithe - 2005 through 2016 (in Millions)






North American Division Missions (in millions) For Past 10 Years






North American Division Tithe Gain (Loss) for 10 Years in Dollars



Distribution




2017 Adjusted Gross Tithe used for the 2019 Tithe Budget

2019 GC/NAD Tithe Income





2018 Payroll Assumptions Remuneration Factor






January – Sept 2019 \$5,011 RF Actual – 1% Canada

Sept — Ded 2019 \$5,136 RF Proposed — 2.5% Canada




2019 Budgeted NAD Use of Tithe Funds:


